- We have run 20+ successful meetings 😊
~40-110 attendees each time
- Mailing list of ~800 people
- Programme Committee
- Member Organisations
- Board
- Committed regular volunteers
- Secure ongoing financial base

UKNOF Remit



- From Charter:
 - *“To pro-actively support the sharing of knowledge, ideas and best practices to enhance the effective, stable and secure operation of the UK's Internet infrastructure as a whole.”*
 - *“UKNOF's remit is technical, and any discussion or activities involving commercial, legal or political issues should be limited to where they have a direct impact on technical aspects of network operations.”*

UKNOF Activities




- *“Distribution of clue”* 😊
- Meetings 3 times/year
 - Current, interesting, stimulating, relevant sharing of knowledge, experiences and best practices
 - Wider-ranging and less specific remit than other UK Internet bodies
 - OPEN to all, bring in new blood
 - Bring world-class international speakers to UK audience
- Mailing list, LinkedIn and Facebook groups
 - Mostly announcements

UKNOF Meetings



- 3 times per year
 - At least one per year in London
 - At least one per year outside London
- Dates are now notionally 3rd Thursday of every Jan, Apr & Sep
 - subject to venue/calendar etc availability
- We are always looking for hosts/venues/sponsors

UKNOF Facilities



- Web site, DNS and internal e-mail currently hosted on Keith's server
- Co-lo and transit for this donated to UKNOF by Jump Networks
- Mailman mailing list hosted by LONAP
- Various parties help with VoIP, meeting and webcast connectivity/archive

Funding Model



- Non-profit
- We prefer to avoid charging meeting registration fees if at all possible
- This has been possible through per-meeting vendor sponsors
- Used idea of “subscriber sponsors” to help build operating reserves in early days
- We now have a good operating cash buffer so this is less critical

UKNOF Running Costs



- Typically about £6k per meeting:
 - venue ~£2k
 - catering ~£2k
 - admin, misc expenses ~£2k
 - connectivity, webcast
- around £65/head/meeting
- About 10% FTE Chair's time
 - contributed by ISC, as part of their public benefit remit
 - Keith's day job is VP of Systems Engineering at ISC
- About 15-20 days/yr Admin time
- Detailed accounts available on request

UKIF Ltd and UKNOF



- The UK Internet Forum (UKIF Ltd) was set up as an alternative Internet trade association in 2005
- Hosted UKNOF secretariat as part of a number of proposed activities
 - Does bookkeeping, invoicing, holds bank accounts, and provides legal entity for UKNOF
- In practice supporting UKNOF has been its only activity for past ~5 years
- Public company limited by guarantee

UKNOF Governance



- Idea is to put things on a more formal footing, without overthinking or creating structure with too much overhead
 - “if it ain't broken don't fix it”
- UKNOF has effectively done a “reverse takeover” of UKIF Ltd
- UKIF legal entity is now dedicated to supporting UKNOF

Finances



- UKIF accounts closed out at end-2010 so they no longer have any residual non-UKNOF elements
- Residual UKIF assets have been transferred to UKNOF
- We have reserves for around a year of meetings

UKNOF's Members



- UKIF Ltd Membership opened up to UKNOF stakeholder *non-profit* Internet organisations that contribute in some way to UKNOF's operation
- Member appointment is by invitation from and approval by existing company members
 - Members sign a simple MoU
- Previously, UKIF's members were it's Directors – at Board meeting on 8th Sep, they appointed the new members
- Membership in perpetuity unless resign or terminated for cause

Membership



- These organisations were appointed in recognition of their support to UKNOF:

- *Other possible candidate member organisations might include ISPA, ISoc, Nominet...*

UKNOF/UKIF Board



- Was appointed by members on 8th Sep
- Directors:
 - Denesh Bhabuta (*Executive*)
 - Willie Black (*Chair*)
 - Steve Dyer
 - Mike Hughes
 - Keith Mitchell (*Managing Director*)
 - Nigel Titley
- 1/3rd of board must step down for reappointment each year, each Director must do so every 2 years

Member and Board Powers



- Company members can:
 - elect new board members
 - remove board members
 - be legal entities or natural persons
- The Board:
 - can appoint and remove programme committee members
 - signs off finances
 - can be natural persons only
 - has usual Company Director fiduciary duties

Supporting UKNOF



- Company Members are not expected to make an ongoing financial commitment to UKNOF, but are expected to devote time and other in-kind resources needed for its smooth operation
- A new category of "supporters" can be created for commercial organisations that help UKNOF materially on an ongoing rather than per-event basis - these would receive recognition but not membership
- Individual membership for meeting attendees is something we considered, but we're not quite in shape to support that yet
- In the meantime we believe that our member organisations are accountable to the wider community through their own stakeholders

Other Details



- While in principle could change entity name of *UKIF Ltd* to *UKNOF Ltd*, this is a lot of paperwork for mainly cosmetic gain
 - currently effectively “UKIF Ltd trading as UKNOF” works
- Programme Committee remains as is
 - but gains formal “new blood” mechanism
- Former “*Funding Council*” replaced by company Members and Board

Board Work Items



- Finalise Member MoU text and get sign-off
- Review Articles and amend if needed
- Define volunteer, speaker expenses policy
- Review Programme Committee composition and create appointment/rotation guidelines
- Create sponsor/supporter framework
- Review governance model in a year and explore possibility of an individual member model
